

ORDER

In reference to the recruitment notice vide memo no- DHFWS/2589/22 dated: 30.06.2022 Sri. Dipanjan Bhunia C/o Dilip Kumar Bhunia residing at Payrachali ,Dalbarh, Chandipur, Purba Medinipur-721633, is hereby engaged on contract basis for the position of **Laboratory Technician** under XV-Finance Commission Health Grant. He will be posted at BPHU, Oodlabari RH, Mal Block, Jalpaiguri and will get a consolidated monthly remuneration of Rs. 22,000/- (Twenty two thousand) only from concerned activity head of XV-Finance Commission Health Grant.

The above mentioned candidates is hereby engaged as per the terms and condition mentioned below:

1. The engagement is subject to the final outcome of the petition filed WPA (P) 335 of 2022 Pijush Patra Vs. The State of West Bengal
2. The engagement is made purely on contract basis till 2025-2026 i.e. it will be co-terminus with the tenure of XV-Finance Commission Health Grant.
3. However, the contract period will be renewed every year based on satisfactorily performance of the candidate.
4. There will be no enhancement of remuneration during the tenure of his/her contract period.
5. No transfer request will be entertained during the engagement period.
6. This engagement will take effect from the date he/she joins the position.
7. The service may also be terminated by one month's notice from either side.
8. If the incumbent proposes to give up his/her work without covering 1 (One) months notice period, his/her remuneration will be deducted accordingly.
9. The candidate has to produce a Medical Fitness Certificate from the registered Medical Practitioner (holding MBBS degree) in the enclosed format and a valid photo identity proof of himself/herself at the time of joining the position.
10. He/She is hereby directed to report for joining in the designated position to the undersigned.
